*Setup access opens 2 hours before the start of each event day. *For the safety of the pilots and guests, no vehicles, trailers, or campers may be moved during the scheduled event. *Access to the runway or assigned vendor spot for setup/breakdown is available before or after the scheduled event only - not while the event is taking place. *Generators are welcome. *Electricity is not available. *Vendors must supply any necessary tables, tents and chairs. *Canopies and tents must be properly weighted (open airfield - it gets windy). *No pets or animals are permitted, other than service animals. *No balloons. *No flags or large banners. *Responsible for cleaning up after the event, including any trash or spills in the assigned area. *BOLD Aviation reserves the right to decline any application at any time, for any reason; if an application is declined after payment has been received, a full refund will be issued. *Refunds otherwise: no refunds will be provided after payment has been received, unless the event is fully cancelled due to weather (weather delays not included).

Release of Liability

I, the undersigned, on behalf of myself, and all working with me, do indemnify and hold harmless National STOL, BOLD Aviation, Lebanon Municipal Airport, and the City of Lebanon against all liabilities and claims of any kind, including attorney's fees, brought by any person or entity that might arise from participating in the Event.
